PARADE DATE: April 15, 2017 - Line-up begins: 9:30 a.m. Parade starts: 11 a.m.

Entry Deadline: April 3rd - entries received after that date will be placed at the end of the parade.

LINE UP:

- Sign-in from 9:30 a.m. at First St. & Lincoln Ave. to receive line-up number and line-up location where directed on First St. from Union Ave. to Lincoln Ave.
- The judges will be on the South (left) side of the street at Ave. A
- Entry haulers, buses, and vehicles should be parked West of Avenue E - Right Side of First St.

WHAT YOU NEED TO KNOW ABOUT OUR PARADE:

- All Vehicles must be decorated!
- Commercial entries (any entry that displays a business name) will be charged an entry fee, see entry form.
ONLY EXCEPTION: Little League and Youth Sports Sponsor Vehicles.
- Please remember to fill in the length of your unit, number of persons in unit, and most appropriate category for judging. **ALL ENTRIES are limited to 5 vehicles - see Parade Application.**
- Day of Parade: Send 1 representative to sign in for parade line-up number and location (9:30 - 10:15 a.m.) All entries should be in place no later than 10:45 a.m.
- Provide Parade Day Entry Contact and Cell Number **FOR EMERGENCY OR OTHER INFORMATION FOR PARADE ENTRY PARTICIPANTS.**
- Awards will be given for 1st, 2nd, and 3rd place in each category immediately following the parade at the judges stand on the South side of 1st St. and Ave. A.

CROWD SAFETY & PARADE POLICY NO EXCEPTIONS!

CHILD SAFETY: Do not throw candy or hand it out from any parade vehicle. Parade Marshall's can remove your entry from parade for violating this policy! **Candy and flyers must be handed out by going to the edge of the crowd, place candy on the ground or hand it to an individual! See Parade Entry Form for Clean Up Fee or Flyer and Candy Distribution.**

JUDGES REVIEW: All judging stand performances are to be no longer than 1 minute.

PARADE ENTRY GAPS: Parade Marshalls will monitor parade flow and instruct entries to close any gaps. Parade Entries must comply.
